## [Kyrgyz Republic] COMMANDANT'S OFFICE OF BISHKEK ORDER NO. 13 DATED MARCH 29, 2020 BISHKEK

## On amendments and additions to the order of the commandant of Bishkek No. 7 dated 03.27.2020

In pursuance of the Decree of the President of the Kyrgyz Republic dated March 24, 2020 No. 55 "On the declaration of a state of emergency in the territory of Bishkek", in order to optimize the sanitary and epidemiological posts set up around the perimeter of Bishkek, I **order**:

- **1.** To relocate the following sanitary-and-epidemiological posts set up around the perimeter of Bishkek:
  - 1. At the intersection of Zhibek Zholu-Lermontov streets;
  - 2. At the intersection of Auezov-Saliev streets;
  - 3. At the intersection of Auezov-Chui streets;
  - 4. At the intersection of Kalinin-Saliev streets;
  - 5. At the intersection of streets Kozhobergenova-50 let Pobedy;
  - 6. At the intersection of Kozhobergenova-Semetei streets;
  - 7. At the intersection of M. Gvardiya-Saadaev streets;
  - 8. At the intersection of T. Moldo-Saadaev streets;
  - 9. At the intersection of the streets Povorot-Frunze;
  - 10. Vasilievsky tract Dacha.
- **2.** Along the perimeter of Bishkek, additionally to set up sanitary and epidemiological posts on the following roads and streets:
  - 1. Obyezdnaya-Kelechek-15 streets (Kelechek);
  - 2. Obyezdnaya -Ibraimova 4 streets;
  - 3. Kozhobergenova (landmark final stop in Chon-Aryk village);
  - 4. At the intersection of M. Gvardiya- MYK bridge;
  - 5. At the intersection of Kirgizskaya-MYK bridge;
  - 6. At the intersection of Profsoyuznaya-Kustanayskaya (Vostochnaya) streets;
  - 7. At the intersection of Zhibek Zholu-**БЧК** bridge (landmark restaurant "Volna" in Novo-Pokrovka);
  - 8. At the intersection of Kalinin- **БЧК** bridge
  - 9. At the intersection of Lermontov- **БЧК** bridge;
  - 10. Semetey-border with Nizhnii Orok village (landmark southwest cemetery).
- 3. To abolish the following sanitary and epidemiological posts on the perimeter of Bishkek:
  - 1. At the intersection of Auezov-Tolstoy streets;
  - 2. At the intersection of Auezov-Kolbaev streets:
  - 3. At the intersection of Auezov-Ankara streets:
  - 4. At the intersection of April 7-Tokonbaev streets;
  - 5. At the intersection of Auezov-**F**4K streets (microdistrict Tunguch);
  - 6. At the intersection of Chortekov-Kuyukov streets;

- 7. At the intersection of Semetey-Rysmendeyev streets;
- 8. At the intersection of Alykulov-Tolstoy streets;
- 9. At the intersection of Alykulov-Murmansk streets;
- 10. At the intersection of Alykulov-Belgorodska streets.
- **4.** To authorize the deputy commandant of Bishkek, the commander of the Ground Forces of the Armed Forces of the Kyrgyz Republic (Karasartov A.O.), to ensure that the required number of military personnel is put up at sanitary and epidemiological posts with full uniforms.
- 5. To authorize the head of the Main Traffic Safety Department of the Ministry of Internal Affairs of the Kyrgyz Republic (Israilov A.B.) to ensure that the required number of staff of the entrusted units is put up at sanitary and epidemiological posts with full uniforms.
- **6.** To assign the responsibility for compliance with this order to the deputy commandants of Bishkek, Karasartov A.O. and Dzhumagaziev K.S.
- 7. General control over compliance with this order rests with me.
