Bishkek April 2, 2020

On approval of the Instruction on verification of electronic passes for movement of vehicles in Bishkek during curfew

(As amended by Bishkek Commandant's Office Order No. 23 dated April 2, 2020)

For the purposes of electronic interaction for obtaining passes for movement of vehicles in Bishkek during curfew, and in accordance with Article 17 of the Constitutional Law of the Kyrgyz Republic "On the State of Emergency", I order:

- 1. To approve the Instruction on verification of electronic passes for movement of vehicles in Bishkek during curfew (Annex 1).
- 2. To approve a sample form of electronic pass for movement of vehicles in Bishkek during curfew (Annex 2).
- 3. To approve the Regulation on refusal to issue the electronic pass for movement of vehicles in Bishkek during curfew.

- 4. To authorize Deputy Director of the State Enterprise "Tunduk" under the State Committee for Information Technologies and Communications of the Kyrgyz Republic (A. Burzhuev) to ensure the timely operation of the information system for issuing electronic passes for movement of vehicles in Bishkek during curfew.
- 5. To assign the consideration of filed electronic applications and issuance of decision to the group of Bishkek Commandant's Office working with passes.
- 6. To authorize deputy commandants of Bishkek, A.O. Karasartov and K.S. Dzhumagaziev, to instruct the staff of the checkpoints in Bishkek on the procedure for checking electronic passes with the help of a training video posted on the website "1312.tunduk.kg".

- 7. To assign the control over compliance with point 3 of this Order to the deputy commandant of Bishkek, S.N. Niyazbekov.
 - 8. Control for compliance with this Order rests with me.

Annex 1

to Bishkek Commandant's Office Order No. 21 dated April 2, 2020

INSTRUCTION on checking electronic passes for movement of vehicles in Bishkek during curfew

The authorized employee of the checkpoint during curfew shall:

1. Introduce himself/herself in the prescribed manner, stating his/her title, rank, surname, and present an official certificate at the request of a citizen.

- 2. Inform the reason for the stop and request presentation of the appropriate pass / electronic pass (in printed or electronic form).
- 3. If necessary, the employee is recommended to scan a QR code of electronic pass in printed or electronic form to verify the data.
- 4. When scanning a QR code using a mobile phone's camera, the system will offer to visit the website or open a document. The employee shall visit the website to obtain data on the issued electronic pass.
- 5. The employee must verify the information stored in the online system with the data of the presented pass for compliance.
- 6. If the pass does not match the information in the online system, the authorized employee is authorized to take appropriate measures against the person committing a violation of the state of emergency.
