On setting up checkpoints in Bishkek

Pursuant to the Decree of the President of the Kyrgyz Republic dated March 24, 2020 UP No.55 "On the declaration of a state of emergency in the territory of Bishkek city, Kyrgyz Republic", in order to prevent the spread of coronavirus infection, ensure safety, protect life and health of citizens in the territory of Bishkek, as well as in connection with the introduction of a special regime for the entry and exit of citizens into the territory of Bishkek and restricting the movement of vehicles, I **order**:

1. to set up checkpoints on the following roads and streets in the territory of Bishkek:

12. April 7th str. - Panorama;

2. To authorize the deputy commandant of Bishkek, the commander of the Ground Forces of the Armed Forces of the Kyrgyz Republic (Karasartov A.O.) to ensure the deployment of 6 troops at the above posts with full uniforms, in consultation with the Bishkek Department of Internal Affairs.

3. To authorize the deputy commandant, head of the Main Department of Internal Affairs of Bishkek (Dzhumagaziev K.S.) to assign the necessary number of officers of the Bishkek Internal Affairs Department to the above posts;

4. To authorize the Bishkek Department of the Ministry of Emergency Situations of the Kyrgyz Republic (Chargynov A.M.) to ensure that 1 officer is assigned for each checkpoint;

5. To authorize the Minister of Healthcare (Cholponbaev K.S.) to provide each checkpoint with 2 health professionals.

6. To authorize the Bishkek Department of the State Registration Service under the Government of the Kyrgyz Republic (Berikbaev B.Zh.) to provide 2 officers with contact readers to check the registration of citizens entering the city of Bishkek for 12 hours per checkpoint.

7. Responsibility for compliance with this order will be assigned to the deputy commandants of Bishkek.

8. General control over compliance with this order rests with me.
