On ensuring the operational activities of the Bishkek commandant's office during a state of emergency in connection with coronavirus infection

Pursuant to the Decree of the President of the Kyrgyz Republic dated March 24, 2020 UP No.55 “On the declaration of a state of emergency in the territory of Bishkek city, Kyrgyz Republic”, and also in order to and speedily normalize the crisis situation associated with the spread of coronavirus COVID-19, I **order**:

1. To authorize the Bishkek Department of the Ministry of Emergency Situations of the Kyrgyz Republic (Chargynov A.M.):
 - to supply checkpoints set up in the territory of Bishkek with necessary equipment and supplies (tents, tables, chairs, heaters, communications, dry closets, etc.).
2. To authorize the Ministry of Healthcare (Cholponbaev K.S.):
 - to ensure round-the-clock duty of two health professionals with necessary equipment (protective suits, thermal imagers, electronic thermometers) for each checkpoint set up in Bishkek with the creation of an algorithm of medical actions;
 - to create 4 mobile groups from among health professionals for each district of Bishkek to check citizens for clinical manifestations by measuring body temperature.
3. To authorize the Bishkek Centre of State Sanitary and Epidemiological Supervision (Beishenalieva A.) and Municipal Enterprise (Sarpashov R.A.) of the Mayor's Office of Bishkek to perform disinfection of the territory of Bishkek, according to a certain perimeter and in places of observation.
4. To authorize the Bishkek Centre of State Sanitary and Epidemiological Supervision (Beishenalieva A.) to collect test samples from the officers of Bishkek Departments of Internal Affairs who are in the service of maintaining public order in the observations located in Bishkek, as well as from suspects in temporary detention centers in Bishkek.
5. To authorize the Commander of the Military Internal Security Service of the Ministry of Internal Affairs of the Kyrgyz Republic (Kenzhekulov I.A.) to prepare places for temporary detention of persons delivered for violation of curfew requirements in the territory of Bishkek, at the address: 281 Orozbekov St, Bishkek.

6. To authorize heads of district departments of internal affairs of Bishkek (Kazakeev A.A., Sultanov U., Kuluyev M.R., Tagaev A.G.) to assign 6 officers per each building of the special unit "Sher" of the Internal Service of the Internal Security of the Ministry of Internal Affairs (former reception center) at address: 281 Orozbekov St, Bishkek, to perform the identification and application of appropriate legal measures against persons who violated curfew requirements.
7. To authorize the Deputy Commandant - Mayor of Bishkek, Surakmatov A.E.:
- to provide persons, military officers, health professionals serving on checkpoints set up in Bishkek with three meals a day;
 - to allocate transport to ensure round-the-clock transportation of employees of medical institutions in Bishkek and, in coordination with the Ministry of Health of the Kyrgyz Republic, to develop a route for their movement;
 - to organize places for the delivery and upkeep of persons without a certain place of residence that violate curfew requirements;
 - to provide vehicles to mobile medical groups;
 - to set up stands at the checkpoints with orders issued by the commandant of Bishkek, templates of applications, requests for permission to freely travel through the checkpoints, as well as templates of certificates issued by the commandant office of Bishkek;
 - to organize works to support socially vulnerable people in Bishkek;
 - to ensure compliance with this order until 6:00 p.m. of March 27, 2020.
8. To authorize the deputy commandants of Bishkek to take all necessary measures aimed at the effective implementation of this order.
9. To entrust the control over compliance with this order to deputy commandants Surakmatov A. and Dzhumagaziev K.S.
