## **ORDER**

March 28, 2020 Bishkek No. 9

## On coordination of measures to prevent the spread of coronavirus and to ensure food security in the territory of Bishkek

Pursuant to the Decree of the President of the Kyrgyz Republic dated March 24, 2020 UP No.55 "On the declaration of a state of emergency in the territory of Bishkek city, Kyrgyz Republic", in order to coordinate measures to prevent the spread of coronavirus and to ensure food security in the territory of Bishkek, I **order**:

- 1. In order to monitor food security in Bishkek, to authorize:
  - the Bishkek Department of the State Service for Combating Economic Crimes to provide information on stocks of 12 main types of food (as per annex hereto) and fuel products, as well as facts of suppressing unreasonable and speculative price increases for the goods indicated in the table every day at 10 am and 6 pm;
  - the district municipalities of the Mayor's Office of Bishkek to provide information (as per annex hereto) on the situation at shopping malls and markets and shopping centers in Bishkek (data on prices for 12 main types of food, information on the percentage increase in value, information about their stocks and shortages, as well as the facts of speculation) on a daily basis at 10 am and 6 pm.
- 2. In order to take timely measures to identify, screen, and isolate infected persons, to decide as soon as possible on the involvement of laboratories of the Centre of the State Sanitary and Epidemiological Supervision in Bishkek, veterinary laboratories at the Ministry of Agriculture and Amelioration of the Kyrgyz Republic, as well as private laboratories ("Bonetsky", "Yurfa", "Aqua", etc.) in collecting rapid test samples from Bishkek resident as soon as possible.
- 3. In order to quickly identify infected citizens and their contacts in the territory of Bishkek, to establish the operational command center at the Mayor's Office of Bishkek composed of the representatives of:
  - the Mayor's Office of Bishkek (Deputy Mayor of Bishkek for social issues);
  - State Committee for National Security of the Kyrgyz Republic in Bishkek (not lower than the deputy chief);
  - Bishkek Main Department of Internal Affairs (not lower than the deputy chief);
  - the Bishkek Centre of the State Sanitary and Epidemiological Supervision (Head of the Center);
  - City Health Department of the Mayor's Office of Bishkek (Head of Department);
  - District municipal administrations of the Mayor's Office of Bishkek (heads of municipalities);
  - Ambulance station in Bishkek (head of Department).
